Manager's Monthly Report – Jason

Jason met with the Planned Giving Committee in January.
In May a panel discussion will be held on Planned Giving.
There were 2 Christmas lunches held in December with about 130 participants. Mayor and City Council members served at one or both.
Fundraising: Total for December is \$10,916. Friends of PSC received a grant from United Way in the amount of \$12,942. The Christmas gift wrap at Crossroads Mall netted about \$700. This was a 3 day event.
“The City of Portage received a \$250,000 grant from the federal stimulus package, of which \$41,000 is dedicated to the PSC for windows and insulation included as a line item in this grant.”
In May there will be a garage sale Mothers Day weekend. Volunteers will be needed to work before and during the sale.
Mary Lou Petrulio was asked to represent the PSC at an upcoming City Council meeting to give an update on current activities for PSC.

Wellness – the Wellness program is off to a good start with the Food Glorious Food - series of speakers, mindful eating PATH program, and Borgess Dietician. PATH is personal action toward health. There is a diabetic support group, vision program – Jan 21, Upcoming will be Matter of Balance – Westland Meadows, Spring Valley, Michigan Commission on the blind presentation for PATH, further networking and collaborating in the community.

Membership – there was discussion on how to retain current membership for the Senior Center and attract new members. It was moved by Art Roberts and seconded by Gordon Heikkila that a committee be formed to report to the advisory council on this matter.

Old Business – The Christmas party held at Oakland Hills Clubhouse was enjoyed by all who attended.

New Business Gordon is working with Jason on getting Windows 7 for the computer lab. Ruth Ann Meyer and Mary Lou Petrulio and Jason attended a KCASI meeting on Jan 18. This is Kalamazoo County Advocates for Senior Issues. There were state legislators present.
