CONTEST OVERVIEW

To promote recycling in the City of Portage, we are holding the second annual sculpture event using 100% recycled materials that will be displayed in Celery Flats for one week. This is not a juried art show but a venue for artists to express their creativity and create public awareness on recycling. Public voting and judging will be conducted with prizes awarded on the last day of the event. All artwork will be displayed outside at Celery Flats for public viewing.

MEDIA

Acceptable media must contain 100% recycled materials (except for bonding devices such as screws, nuts and bolts, welding, glues and other fastening materials). The focus is on materials that were originally manufactured and would be thrown away. Your creativity will provide a new life for materials that would otherwise be discarded. We are looking for sculpture that would use materials in a manner that is different from its intended use and reformed into a work of art.

PRIZES & JUDGING

Prizes will be awarded in a variety of categories including a Popular Choice from visitor voting conducted on designated day(s) and/or the website. A panel of area artists will judge the artwork based on adhering to the recycling content for eligibility, with 60% creative use of materials as they were not originally intended, and 40% overall artistry and originality. The Judging panel will be conducted on Saturday, May 10, 2014, with prizes awarded that day for 1st, 2nd, 3rd, and Sponsor's Choice Awards. The Popular Choice Award will be announced on Saturday, May 17, 2014:

- 1st Place
- 2nd Place
- 3rd Place
- Sponsors Choice
- Popular (Public) Choice

Prizes will need to be picked up at the City of Portage; Parks Department office located at 7900 S. Westnedge, Portage, MI 49002, no later than Monday, June 30, 2014 or the winner will forfeit the prize. Prizes are not redeemable for cash, or transferrable.

HOW TO ENTER

Limit of one entry per person or organization postmarked no later than March 14, 2014. A fifty dollar (\$50) deposit is required with your entry form and will be refunded after the event and the artwork is removed from the Park. A check or money order should be made out to the City of Portage and mailed to the location on the entry form. Classes from K-12 schools, colleges or universities submitting a sculpture (one entry per class) can waive the \$50 entry fee deposit by submitting a Letter of Intent or Commitment on school letterhead and signed by the teacher, with their entry form to hold their spot in the contest. Entrants will be asked on the entry form to list the materials used for their sculpture. All artwork must fit into the designated 10' x 10' space with no exceptions. Artist are responsible to ensure that their art is secure, weatherproof, and provides any mounted surface or structure if needed.

DEADLINE

Entry forms with accompanying entry fees (or Letter of Intent /Commitment) must be postmarked no later than March 14, 2014. Entrants will be notified of acceptance into the show no later than March 28, 2014. There will be a limit this year of 30 entrants accepted on a first received basis.

SET UP & PICK UP

Entrants will be responsible to set up and remove their artwork. Please bring appropriate personnel and transportation devices to move your sculpture into its 10' x 10' exhibit space. The exhibit space will be outdoors and will not be secured, but every effort will be made to monitor the Park. Set-up will be on Friday, May 9 from 3:00 to 8:00 p.m. ONLY. All work must be secured and left on-site for public display and voting, and must be picked up no later than Sunday, May 18 at 5 p.m. or your \$50 entry fee will not be refunded. The first place winning sculpture will be moved by the artist and displayed until August 30, 2014 at a public site designated by contest officials. A photographer will be on-site during setup to take pictures of the artist(s) with their sculpture to be used for future publicity efforts. Every effort will be made to get photographs of each entrant, and your assistance with the photographer is appreciated. The City of Portage and Park Board of Directors are not responsible for any damage to artwork. Additional set-up instructions will be sent to each entrant by April 11, 2014.

ELIGIBILITY

Any individual is eligible to participate, including, K-12, college and university classes, except employees of the City of Portage and City of Portage Parks Board Members are not eligible to enter. By entering the contest you consent to have your submitted artwork featured and published for publicity purposes. Artwork will not be accepted if it is deemed obscene, threatening, and/or offensive as deemed by contest representatives.

WINNERS

Winners will be notified by email or phone by the end of day May 16, 2014. It is up to the entrant to ensure correct contact information is listed on the entry form. Contest administrators will make at least three attempts to contact the winner and it is up to the winner to acknowledge contact by return email or phone call. After June 30, 2014 if no contact has been received from the winner the prize will be forfeit. Winners will be required to show proof of identity when picking up their prize. All taxes are the sole responsibility of the winner. Winners' names and /or images will be posted on the website and be publicized for promotional purposes. The first place winning sculpture will be put on display through August 30, 2014 at a public site designated by contest officials.
