PLEASE TAKE NOTICE that on the 13th day of May, 2014, at 7:30 p.m. or as soon thereafter as may be heard, a public hearing will be held at the City Hall in the City of Portage, Michigan on the request of MANIN+HUMMEL USA, INC., for the expansion of Industrial Development District No.48 under Michigan Act 198 of P.A. 1974.

PLEASE TAKE FURTHER NOTICE that said district is commonly described as property located at 6400 Sprinkle Road, Portage, Michigan, and more particularly described as follows:

A PARCEL OF LAND LOCATED IN THE NORTHWEST QUARTER OF SECTION 12, TOWN 3 SOUTH, RANGE 11 WEST, CITY OF PORTAGE, KALAMAZOO COUNTY, MICHIGAN, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTH QUARTER POST OF SAID SECTION; THENCE WEST ALONG THE NORTH LINE OF SAID SECTION 50.0 FEET TO THE WEST LINE OF SOUTH SPRINKLE ROAD; THENCE SOUTH 00°-41'-50" WEST THEREON AND PARALLEL TO THE NORTH AND SOUTH QUARTER LINE, 1960.73 FEET FOR THE PLACE OF BEGINNING OF THE LAND HEREINAFTER DESCRIBED; THENCE CONTINUING SOUTH 00°-41'-50" WEST ALONG SAID WEST LINE, 522.37 FEET; THENCE NORTH 89°-54'-30" WEST PARALLEL WITH THE SOUTH LINE OF SAID SECTION, 447.85 FEET; THENCE SOUTH 00°-41'-50" WEST PARALLEL WITH THE NORTH AND SOUTH QUARTER LINE, 175.0 FEET TO SAID SOUTH LINE; THENCE NORTH 89°-54'-30" WEST THEREON, 798.02 FEET TO THE EAST LINE OF THE NORFOLK SOUTHERN RAILROAD RIGHT-OF-WAY (FORMERLY PENNSYLVANIA, G.R. & I.R.R.); THENCE NORTH 00°-57'-40" EAST ALONG SAID RAILROAD RIGHT-OF-WAY, 695.42 FEET TO A POINT THAT IS 1,960.86 FEET SOUTHERLY OF THE NORTH LINE OF SAID SECTION AS MEASURED ALONG SAID RAILROAD RIGHT-OF-WAY; THENCE EAST PARALLEL TO THE NORTH LINE OF SAID SECTION, 1,242.69 FEET TO THE WEST LINE OF SOUTH SPRINKLE ROAD AND THE PLACE OF BEGINNING.
